ACADEMIC PLAN APPLICATION AND DECLARATION

Academic Plan <u>Declaration</u> allows you to declare your major, specialisations, minors (open), and second majors (open) during the main semesters. Please note that you will not be allowed to register for courses unless the Academic Plan has been declared. You are also only allowed to make one declaration per semester. The minimum requirement of your candidature is to read 1 Major Programme and the maximum allowance is 2 Major Programmes with 3 Minor Programmes. Do select the Programmes according to your ability. No amendment is allowed beyond the fifth semester of study. Academic Plan <u>Application</u>, on the other hand, involves the application for closed and restricted minors and second majors. The application period is in April and November, respectively for the following Academic Year Semester 1 and Semester 2. Please look out for the email sent by the Office of the University Registrar (OUR) on Academic Plan Application.

Note: Students are required to submit your major/minor declaration in the Academic Plan Declaration system **at least 24 hours BEFORE** you are allowed to access CourseReg (Course Registration). Only <u>one</u> attempt is allowed per semester, and no changes are allowed after the declaration is submitted. Students may add new Specialisation and/or drop their Second Major/Minor/Specialisation beyond their fifth semester of study. However, students are not allowed to change or opt for a new Second Major or Minor after their fifth semester's Academic Plan Declaration exercise.

Please note that students with a declared major will be given higher priority in the selection of major courses.

Select Courses Rounds

Do note that Round 1 is a protected round, where students will be able to select courses that can be used towards the following:

- Programme (CHS Common Curriculum, Major, Specialisation) requirements
- Second Major requirements
- Direct admission/ Restricted Minor requirements
- Prescribed English requirements (i.e. courses offered by CELC)

Rounds 2 and 3 are open, where students will be able to select all courses* (including General Education courses) that they wish to read for the semester.

*Do note that certain courses might have course restrictions that limit the selection in CourseReg to certain groups of students.

<u>Workload</u>

All Single Degree students can select up to a maximum of 23 Units from Select Courses Round 1 to Round 2. From Round 3 onwards, the workload allowance will be in accordance with the student's GPA.

Do note that the stipulated **minimum workload** that each student should have is **18 Units per semester**. Students are only allowed to underload in their graduating semester, or if they are doing credit-bearing internship.

NUS DATA PROTECTION POLICY AND PERSONAL DATA PROTECTION ACT (PDPA) GUIDELINES

Recently, Singapore has seen multiple cases of data breaches and attacks on our IT infrastructure. Understanding that the University is not immune to these incidents and threats, we have taken direction from the Singapore Personal Data Protection Commission (PDPC) to roll out an e-training course DP1001 NUS Data Protection Policy and Personal Data Protection Act (PDPA) Guidelines to all undergraduates.

All students are required to complete the e-training course, "E-Training Package on Student Essentials" via <u>Canvas</u>.

QUALIFYING ENGLISH TEST (QET)

Students who have yet to take their QET will be notified by the Office of the University Registrar (OUR). The Centre for English Language Communications (CELC) will notify the student of their results after they have taken QET.

- Students who obtain Band 1 will have to take ES1000 followed by ES1103
- Students who obtain Band 2 will have to take ES1103
- Students who obtain Band 3 are exempted from these English courses

Students are strongly advised to complete the required course(s) within the first year of study. Students who are required to read both ES1000 and ES1103 may read ES1000 in the first semester of study and ES1103 in the second semester of study. ES1000 has 0 units and does not count towards the minimum workload. Please refer to the <u>CELC website</u> for more information.



COMPULSORY COMMUNICATION COURSE

CELC and FoS co-developed SP1541 Communication Practices in Popular Science, a compulsory course subsumed under the Writing pillar of the CHS Common Curriculum (see next section) for all Science students (except for students in Environmental Studies, Pharmacy, Special Programme in Science (SPS), University Scholars Programme (USP) / NUS College (NUSC), and students from any Residential Colleges) matriculated in AY2015/2016 and beyond. Students are strongly advised to complete the course within the first year of study. Students who are required to read ES1000 and/or ES1103 should complete reading SP1541 within the first two years of study.

NEW!

Starting AY2024/2025, students reading SP1541 Communication Practices in Popular Science will learn about how science is communicated to non-specialist audiences in various mediums such as science news magazines, TED talks, and digital media. In addition, through collaboration with the Singapore Science Centre (SSC), students will experience communicating science to diverse audiences through introducing and explaining specific exhibits to visitors at the SSC. Those who choose to read SP1541X will engage different audiences in a Southeast Asian country, on a sevenday trip which includes field trips to places practising environmental and sustainability efforts. Vacancies for SP1541X is capped at 36 through CourseReg.

CHS COMMON CURRICULUM

The CHS Common Curriculum is designed to impart essential skills and broaden intellectual foundations. Students reading a major under CHS are required to read the CHS Common Curriculum as part of their graduation requirements. The common curriculum consists of 13 courses:

- 1. Humanities
- Social Sciences 2.
- 3. Asian Studies
- Scientific Inquiry I
 Scientific Inquiry II
- 6. Artificial Intelligence
- 7. Data Literacy

- 8. Digital Literacy
- 9. Design Thinking
- 10. Communities and Engagement
- 11. Writing
- 12. Interdisciplinary Course I
- 13. Interdisciplinary Course II

Students would only have to read one course from each pillar. The courses that can be read to fulfil the respective pillars are summarised in the table below.

*SP2271, SP2273 and SP2274 are open to all CHS students and fulfil the respective CHS Common Curriculum pillars. These courses are mandatory for students in the Special Programme in Science. *Only students reading the MA-CS DDP and/or SoC's Artificial Intelligence minor/Computer Science second major/minor can use CS2109S to fulfil the Artificial Intelligence requirements.

Students are strongly encouraged to complete all CHS Common Curriculum courses within the <u>first 2</u> <u>vears</u> of their candidature, except for the following three courses:

- Communities and Engagement can be taken in their 2nd year onwards*
- Two interdisciplinary courses can be taken in their 3rd or 4th year

CHS Common Curriculum Course Pre-Allocation

Several courses of the CHS Common Curriculum will be pre-allocated to students across their first two semesters, depending on their major. More information on the pre-allocation plans for the respective majors can be found on the FoS website <u>here</u>.

Students who are enrolled in and have read courses from the USP, NUSC, University Town College Programme (UTCP), Ridge View Residential College Programme (RVRC) or Special Programme in Science (SPS) may be able to map to some of the 13 courses of the CHS Common Curriculum. Students are required to read the remaining outstanding course(s). More information can be found on the FoS website <u>here</u>.

GENERAL EDUCATION (GE) CURRICULUM

Students admitted from AY2021/2022 onwards (except students from Law, Medicine, Dentistry) will experience a new curriculum introduced by the GE Reform, which aims to ensure that the GE curriculum continues to provide a unique and relevant learning experience for students to thrive in today's rapidly changing world. The new curriculum features the following six pillars:

- i. Cultures and Connections
- ii. Critique and Expression
- iii. Data Literacy
- iv. Digital Literacy
- v. Singapore Studies



vi. Communities and Engagement

Students are required to read one course from each pillar to fulfil their GE requirements. These 6 pillars are embedded within the CHS Common Curriculum, hence CHS students will satisfy the GE requirements upon completion of the CHS Common Curriculum.

The CHS Common Curriculum that are mapped to the GE pillars are as follows:

For each Major, up to 8 Units may be used to meet (i) the Major requirement and (ii) the General Education or College (e.g., Common Curriculum) requirement.

MAXIMUM UNITS FROM LEVEL-1000 COURSES

Before applying for graduation, please ensure you have at most 60 Units of Level-1000 courses; any excess does not count toward the total Units graduation requirements. The following courses do not count toward the 60 Units limit:

- CFG1002 Career Catalyst (2 Units)#
- CFG1004 Financial Wellbeing Art and Science of Investing (2 Units)#
- CFG1500 Women's Professional Development Programme (2 Units)#
- CFG1600 CommsLab Public Speaking (2 units)#
- ES1103 English for Academic Purposes (4 Units).
- Courses under the Design-Your-Own-Course (DYOC) initiative.
- HS1301 Workplace Communication (2 Units)[^].

#Exclusion of CFG1002, CFG1004, CFG1500 from the limit on Level-1000 courses is applicable to:

- BIZ, FASS, FoS, SoC, SDE, and FoE students from Cohort AY2016/2017 onwards.
- ^Exclusion of HS1301 from the limit on Level-1000 courses is applicable to:
 - CHS students from Cohort AY2021/2022 onwards.

DEGREE REQUIREMENTS

Minimum Units Requirements

- i. At least 160 Units in total
- ii. Minimum Units that must be earned from NUS courses <u>https://www.nus.edu.sg/registrar/academic-information-policies/undergraduate-</u> <u>students/continuation-and-graduation-requirements#MinMCRequirements</u>
- At most 60 Units of Level-1000 courses; any excess does not count toward the total Units graduation requirements. For courses that do not count toward the 60 Units limit, please refer to this <u>link</u>.



Second Majors, Minors and Specialisations

i. Second Major

A Second Major programme is conceived as an opportunity for students to broaden their knowledge and capacities by pursuing a second Major alongside their primary Major. The Second Major affords a significant degree of depth, although its Units requirement is set below that of the Major. The Second Major is a non-Honours major.

The requirement for a Second Major is at least 40 Units, of which:

- Up to 16 Units (40% of the Unit requirements for a Second Major) may be used to meet (i) the Second Major requirement and (ii) another requirement, e.g., General Education, College, Faculty requirement outside CHS, Major, Second Major, Minor, Specialisation or other requirement.
- At least 12 Units must be at Level 3000 and above.
- A minimum 60% of the Second Major requirements must be earned from courses read at NUS. Courses read at NUS include all courses taught, co-taught, supervised or cosupervised by NUS faculty members. These consist of graded courses or courses with an 'S' or 'CS' grade. The remaining Units may be earned through credit transfers, advanced placement and exemptions, from courses deemed relevant to the particular Second Major.

ii. Minor

A Minor programme is a coherent course of study in an additional area outside of the Major. By doing this, it contributes to the breadth of learning envisaged for undergraduate education.

The requirement for a Minor is at least 20 Units, of which:

- Up to 8 Units (40% of the unit requirements for a Minor) may be used to meet (i) the Minor requirement and (ii) another requirement, e.g., General Education, College (Common Curriculum), Faculty requirement outside CHS, Major, Second Major, Minor, Specialisation or other requirement.
- At least 12 Units for any Minor programme must be taken from outside the entire set of courses that are listed for the major(s)/another minor that the student is taking/ has taken.
- A minimum of 60% of the total Units of the Minor requirements must be earned from courses read in NUS. Courses read at NUS include all courses taught, co-taught, supervised or co-supervised by NUS faculty members. These consist of graded courses or courses with an 'S' or 'CS' grade. The remaining Units may be earned through credit transfers, advanced placement and exemptions, from courses deemed relevant to the particular Minor.
- iii. Specialisation

A Specialisation is a programme of study on a particular specialised sub-discipline of a higher level within its main discipline.

The requirement for a Specialisation is at least 20 Units of higher-level courses of a specialised nature within a Major. Up to 8 Units (40% of the total requirements for a Specialisation) may be used to meet (i) the Specialisation requirement and (ii) another requirement, e.g., Major, Second Major, Minor, Specialisation or other requirement.

Double Counting policy

Ensure that you do not violate double counting policy:

- a. For major-major, major-minor, minor-minor and specialisation-other requirement.
- b. No triple counting is allowed, i.e. you are not allowed to use one course to satisfy:
 i. 2 majors + 1 minor



- ii. 1 major + 2 minors
- iii. 3 minors
- iv. specialisation with 2 other requirements (for Cohort AY2021/2022 onwards)
- c. Even with double counting, Units will only be counted once toward the minimum Unit graduation requirements.

With the flexibility of the CHS curriculum, you can chart your own education pathway depending on your interests, aptitude and career aspirations. You can choose to be a versatilist, integrator or deep specialist. S/U OPTION ENTITLEMENT

• With the launch of Enhanced Grade-free Scheme with effect from AY2016/2017 Semester 1, students may exercise the S/U option for up to 32 Units in the first year including the first two regular semesters and first year special term. If this is not fully utilised, the S/U option may be exercised in subsequent semesters, for up to 12 Units.

Variations on the limit of S/U options that can be exercised apply for specific groups of students:

- i. Students without prior university experience but are granted 20 or more Advanced Placement Credits (APCs) at the point of admission to NUS may exercise the S/U option for up to 20 Units in the first year; if this is not fully utilised, the S/U option may still be exercised in subsequent semesters, for up to 12 Units.
- ii. Students with some prior university experience (which are being recognised towards the NUS degree) may exercise the S/U option for up to 12 Units anytime during their candidature, including the first year.
- iii. Students with a prior university degree are not eligible for the grade-free scheme.

Key Points to Note

- Both the 'S' and 'U' grade count towards the total S/U Option entitlement
- For courses read on an S/U basis, the Unit is obtained only if a student attains a Satisfactory 'S' grade for the course
- All courses read on S/U basis are excluded from the computation of the GPA
- S/U option, once exercised, is irrevocable. Students may not later request for a conversion to a letter grade

Students who intend to graduate by the end of Semester 2 AY2024/2025 <u>must</u> apply for graduation online. You may go to "Apply for Graduation" via myEduRec from **0000hrs**, **30 December 2024 to 2359hrs**, **10 January 2025** to indicate your intention.

Please also note that My Graduation Audit Report & My What-If Report do not take into account the courses you have not completed and passed. These two reports act as guides to assist you with graduation checks.

The onus is on the students to check their fulfillment of Graduation Requirements based on these two reports. You are strongly advised to refer to the graduation requirements available on the Faculty of Science website and the Bulletin based on your cohort.

Before applying for graduation, you must ensure that you have:

You are reminded to update your declaration of major(s), specialisation and/or minor(s), and remove those that you no longer want. Otherwise, the AFG check will indicate that you do not satisfy the requirements of the major(s), specialisation and/or minor(s) declared, and you may not be allowed to graduate at the end of Semester 2, AY2024/2025.

It is important that students apply for graduation via myEduRec. Students who do not apply for graduation online by the stipulated deadline may have to delay their graduation till Semester 1, AY2025/2026.

Please note that the 60 Units limit on Level 1000 courses is applicable to all courses counted towards DDP. You must also ensure that you have fulfilled all graduation requirements and have declared your major(s), specialisation(s) and minor(s), if any, correctly.

CONTINUATION, PROBATION AND DISMISSAL

To remain in good academic standing, and to continue in an undergraduate programme of study, a student may not have GPA below 2.00 for two consecutive semesters. For any semester in which the student's GPA falls below 2.00, s/he will be placed on probation. If the student's GPA remains below 2.00 for the second consecutive semester, the student will be issued a letter of dismissal by the Office

of the University Registrar and denied re-admission. The student may appeal against the dismissal if there are extenuating circumstances. However, each student is only allowed to appeal <u>once</u> during his/her candidature.

With the launch of Enhanced Grade-free Scheme:

- For students who are eligible to exercise ≥ 20 Units of S/U options, the above continuation rules are applied from the third semester onwards.
- For students who are eligible to exercise ≤ 12 Units of S/U options, the above continuation rules are applied from the first semester onwards.

Students who face difficulties in coping with their studies are encouraged to approach their academic mentors for guidance and support. The respective mentors will be able to guide and advise students on the various avenues where help is available. FEE POLICIES

Tuition Fee Beyond Normal Candidature

With effect from the admission cohort of AY2016/2017, students admitted into an undergraduate degree under the modular system in NUS and who take longer than the normal candidature period to complete their degree requirements will have to pay partial non-subsidised fees, culminating in full non-subsidised fees, during the extended semesters.

In view that the Ministry of Education provides a Tuition Grant to subsidise a student's tuition fees up to the normal candidature period, the tuition fee payable beyond that would be the full non-subsidised semestral fees. To mitigate the impact of higher fees, the University undertakes to charge affected students only a proportion of the full non-subsidised semestral fees pro-rated based on the Units read in the extended semesters. In addition, the pro-rated full fees payable in the first and second semester beyond normal candidature will be capped at 120% and 150% of the subsidised semestral fees respectively.

The fees payable beyond normal candidature period are summarised in the following table:

Students who register for course(s) in the Special Term immediately following the expiry of their normal candidature period will continue to pay subsidised fees on a per course basis. However, for the Special Terms beyond that, the Special Term fees payable will be the full non-subsidised semestral fees prorated based on the number of Units read.
